Scott Allen of Supreme Machine in Ruston won the 2008 Louisiana Small Business Person of the Year award and is one of the District winners from the Northeast Region. Allen was nominated by the Louisiana Tech University Technology Business Development Center. The LSBDC worked two years with Allen helping him improve the efficiency and productivity of his machine shop, which builds customized machine parts.

**Julie Pleasant,** Vice President and Relationship Manager at J.P. Morgan Chase in Monroe won the **Financial Services Champion of the Year** award. She was nominated by the LSBDC at University of Louisiana at Monroe for her diligent work with helping small businesses obtain financing to start and run their operations.
